Project Title: Streambed Alteration Agreement No. 1600-2021-0018-R2 (Rattlesnake Timber Harvesting Plan 4-21-00053-AMA, Sierra Pacific Industries)

Project Location: The projects are located within the boundaries of a timber harvesting plan in Amador County, within CALWATER watershed Rattlesnake Creek and its connecting tributaries; Township 8N, Range 15E, Sections 14 and 24 of the U.S. Geological Survey (USGS) 7.5-minute Peddler Hill, Mount Diablo Base and Meridian.

Project: The projects are limited to installing a temporary bridge and water drafting. Further explanation of work can be referenced within the THP 4-21-00053-AMA.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
