### STATE CLEARINGHOUSE

The California Highway Patrol (CHP) Humboldt Area recently received a request to review the Manila State Route 255 Shared Route Pathway Project. Due to the project location on and around the Department of Transportation (DOT) maintained State Route 255, the CHP Humboldt Area considers the impact to traffic in the immediate area to likely be minor. Access to either side of the project location can be traversed utilizing alternate routes. The CHP Humboldt Area recommends DOT provide adequate signage and traffic control measures to mitigate safety concerns near the project location. Additionally, the CHP Humboldt Area recommends the hours of operation for this project occur overnight and during off-commute hours to best reduce any possible traffic surge through the communities of Manila and Samoa.
