Project Description:

The proposed project includes the demolition and removal of the existing driveways, parking areas, and structures on the site and construction of 50 affordable condominium units and 48 market-rate condominium units at an approximately 6.3-acre site at the northeast corner of the intersection of Moody Street and Orange Avenue (project site) in the City of Cypress (City) that is currently used by the Cypress School District (District) for its administrative and maintenance operations. Occupancy of all 98 units would be restricted to households with at least one member 62 years of age or older. The proposed project will include the subdivision and redevelopment of the project site, and will require approval of a tentative tract map and a Conditional Use Permit for Senior Housing – Affordable by the City of Cypress. As part of a separate project, the District's administrative office would be relocated to a commercial office building located at 5816 Corporate Avenue in Cypress, and the maintenance facilities would be relocated to the currently closed Swain Elementary school site located at 5851 Newman Street, also in Cypress. The District is responsible for preparing any California Environmental Quality Act (CEQA) compliance documentation related to those relocations.
