**Project Title:**

Fern Bacon Middle School SRTS Improvements

**Project Location:**

The project is located along Martin Luther King Jr. (MLK) Boulevard, between 48<sup>th</sup> Avenue and 49<sup>th</sup> Avenue, along 49<sup>th</sup> Avenue, between MLK Jr. Boulevard and Wesley Avenue, along Wesley Avenue between 48<sup>th</sup> Avenue and Cuny Avenue, and along Cuny Avenue, between Wesley Avenue and 42<sup>nd</sup> Street, in the unincorporated portion of the South Sacramento community.

**Description of Project:**

The project proposes the following safe routes to school (SRTS) infrastructure improvements for the Fern Bacon Middle School and surrounding area: 1.) New crosswalk at 48<sup>th</sup> Avenue and MLK Jr. Boulevard; 2.) Infill of new sidewalks from 48<sup>th</sup> to 49<sup>th</sup> Avenue on MLK Jr. Boulevard and from 48<sup>th</sup> Avenue to Cuny Avenue on Wesley Avenue; 3.) Addition of crosswalks to connect the new sidewalk on 49<sup>th</sup> Avenue and Cuny and Wesley Avenues; 4.) Improve the school frontage along Cuny Avenue by adding no parking zones around the crosswalks and loading zones for the remainder during school hours.
