Project Description

The proposed project would perform emergency repairs on Route 101 between post miles (PM) 12.5 and 15.5 in Del Norte County. The purpose of this project is to restore full and efficient access within the project area. Damaged retaining walls, vertical settlement, horizontal shift of the concrete barrier rail, several 12-14" diameter voids within the traveled way, and shoulder failures in several locations require repair. Refer to the bulleted list on page 3 for a description of work included in the project. All work would occur within the State right of way. Biological, cultural, and visual analyses have been completed for the project area.

Description of work:

- Stabilize the lagging of RW #3 and RW #4 (PM 15.2);
- Repair and replace the concrete barrier rail at the base of RW#3 (PM 15.2);
- Repair failing roadway shoulders;
- Repair approximately 100 feet of failed retaining wall at PM 14.4;
- Construct 140 feet of additional retaining wall to south at PM 14.4;
- Replace damaged components/portions of the existing Near Real Time Monitoring System (various locations);
- Place asphalt concrete in the areas where sinkholes within the traveled-way have occurred (various locations);
- Install a camera/video system, which would require establishing a sufficient power supply system (PM 14.5/15.4);
- Replace sinking/failed shoulder and replace and adjust metal beam guard rail (MBGR) along the outside shoulder (various locations from PM 12.5/15.5);
- Place temporary and new asphalt concrete pavement (various locations from PM 12.5/15.5);
- Place new illuminated warning signs and solar powered message boards at key locations to warn the traveling public of potential uneven roadway and/or an active slide area. The message boards would also be utilized in the case landslides cause closures or significant delays (southbound (SB) shoulder PM 15.5; northbound (NB) shoulder PM 12.5);
- Construct a system that would provide lighting for the areas of the site that are most prone to landslide movement, such that the site can be sufficiently illuminated so nighttime construction activities can occur if necessary, at various locations between PM 14.4/14.9 and PM 15.2/15.4;
- Construct a 218-foot shear pile wall at PM 14.37;
- Conduct investigative geotechnical drilling and install monitoring equipment within existing roadway.

The following standard measures and Best Management Practices (BMPs) apply to the project:

- Soil stabilization and sediment control (e.g., silt fences, fiber rolls, gravel bags, straw bale, hydroseeding, and straw mulch)
- Waste management and materials pollution control (material delivery and storage, material use, stockpile management, spill prevention and control, solid waste management, hazardous waste management, concrete waste management, and liquid waste management).
- To protect migratory and nongame birds (occupied nests and eggs), if possible, vegetation removal would be limited to the period outside of the bird breeding season (removal would occur between September 16 and January 31). If vegetation removal is required during the breeding season, a nesting bird survey would be conducted by a qualified biologist within one week prior to vegetation removal. If an active nest is located, the biologist would coordinate with CDFW to establish appropriate species-specific buffer(s) and any monitoring requirements. The buffer would be delineated around each active nest and

construction activities would be excluded from these areas until birds have fledged, or the nest is determined to be unoccupied.

- Straw, straw bales, seed, mulch, or other material used for erosion control or landscaping would be free of noxious weed seed and propagules.
- After all construction materials are removed, the project area would be restored to a natural setting by grading and placing erosion control with native, regionally appropriate species. Standard measures would be implemented as part of the project to ensure invasive species do not proliferate.
