Project Description

The California Department of Transportation (Caltrans) proposes a Director's Order project to replace a culvert at post mile 20.77 on State Route (SR) 88 in Amador County. A sink hole was discovered near the culvert and further investigation revealed the drainage system was compromised. The scope of work includes replacing the existing 8-foot, Corrugated Steel Pipe (CSP) culvert and rock-lined section with a 7-foot by 7-foot concrete box culvert, replacing the headwalls and wingwalls at the inlet, and installing Rock Slope Protection (RSP) at the outlet. All work will occur within Caltrans Right of Way. The purpose of this project is to replace the damaged and failing culvert system. The project is needed to rectify the sink hole and ensure motorist safety across the drainage.

General:

At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.
