

**NOTICE OF INTENT TO ADOPT A
MITIGATED NEGATIVE DECLARATION**

Notice is hereby given that the public agency named below has completed an Initial Study of the following described project at the following location: Southeast corner of Eucalyptus Street and Topaz Road

Project Description:	A Vesting Tentative Tract Map with a Mitigated Negative Declaration to allow for the subdivision of two undeveloped R-1 (Single-family Residential) zoned properties into 65 single-family lots.
Project Location:	Southeast corner of Eucalyptus Street and Topaz Road; APN: 0405-322-08 & 09; Within the City of Victorville, County of San Bernardino, State of California, San Bernardino Meridian, Section 11, Township 4N, Range 5W.

This Initial Study was completed in accordance with the Lead Agency's Guidelines for Implementing the California Environmental Quality Act (CEQA).
