



**NOTICE OF INTENT TO ADOPT AN
INITIAL STUDY/NEGATIVE DECLARATION
6th Cycle Housing Element Update PLAN21-00030**

This serves as the City of Victorville's Notice of Intent to Adopt an Initial Study/Negative Declaration (IS/ND) for the 6th Cycle Housing Element Update, prepared in accordance with the California Environmental Quality Act (CEQA), CEQA Guidelines, and local implementation procedures.

Name of Project: City of Victorville 6th Cycle Housing Element Update

Project Location: Citywide, Sphere of Influence

Lead Agency: City of Victorville, 14343 Civic Drive, Victorville, California 92392

Project Description: The City of Victorville (City) is proposing to update the City's Housing Element for the 6th Cycle planning period from October 15, 2021, to October 15, 2029. The Housing Element is a component of the Victorville General Plan 2030 that assesses the housing needs of all economic segments of the City, defines the goals and policies that would guide the City's approach to resolving those needs, and recommends a set of programs that would implement policies over the next few years.

NOTICE IS HEREBY GIVEN THAT the City proposes to adopt an IS/ND for the above-referenced project. The IS/ND is based on the finding that the project's environmental effects would be less than significant. The reasons to support such a finding are documented in the IS/ND prepared by the City.
