Notice of Intent to Adopt a Mitigated Negative Declaration Well 56 Wellhead Treatment Project

Eastern Municipal Water District (District) proposes to implement the Well 56 Wellhead Treatment Project (Project) to address PFAS concentrations in the groundwater pumped at the District's existing Well 56, taken offline in February 2019. The District proposes to acquire real property to provide a suitable location to construct and operate a wellhead treatment facility and has identified a total of five sites as potential locations for the Project. The potential sites being considered are referred to as the Proposed Project and Options 1 through 4.

The Project is located in the north-central portion of the City of Perris, Riverside County. The Proposed Project, Option 1, Option 2, and Option 4 sites are clustered north of the Ramona Expressway/Indian Avenue intersection. The Option 3 site (the District's existing Well 59 facility) is located on the northwest corner of the Indian Avenue/Nance Street intersection. In addition, depending on the site selected, there would be pipelines constructed in a portion of the public right-of-way (ROW) of Indian Avenue. Option 2 would include a pipeline within the Perris Boulevard ROW. Option 3 would include a pipeline within the Nance Street ROW. Option 4 would include pipelines within the Perry Street ROW.

The Project sites are not on a list compiled pursuant to Government Code Section 65962.5.

In accordance with Section 15072(a) of the State CEQA Guidelines, this Public Notice officially notifies the general public, public agencies, and landowners that a 30-day public review period will begin on September 9, 2021.
