Project Title: Storm Drain Zone 36/39 Improvement (Streambed Alteration Agreement EPIMS Notification No. SJN-38517-R2)

Project Location: The project is located at the San Joaquin River, in the County of San Joaquin, State of California; Latitude 37.775389, Longitude -121.299322 (WGS 84 datum, decimal degrees).

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification Number SJN-38517-R2), pursuant to section 1602 of the Fish and Game Code to the project Applicant, City of Manteca, as represented by David Bahr.

The project includes a regional gravity drain that receives stormwater pumped from multiple detention basins, a Storm Drain Pump Station (SOPS) that conveys drainage from the regional gravity drain to an outfall and to the San Joaquin River, a storm drain force main connecting the SOPS with the proposed river outfall, and a river outfall including dual discharge pipelines and appurtenances.

This is to advise that CDFW, acting as a Responsible Agency, executed the above-described Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered mitigated negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.

4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were made by CDFW pursuant to California Code of Regulations section 15091.
