- DESCRIPTION: The project will improve the existing odor control system and degripping system at the blend tank located at the Main Wastewater Treatment Plant. This project will move the existing odor control system vessels, reconstruct associated piping, replace valves, and install new blowers and monitoring instrumentation. A temporary odor control system will be installed during construction to handle odors while the existing system is out of service.
