DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Complete improvements and repairs at The Eagle Cottage in Columbia State Historic Park to provide greater accessibility for park visitors and to help volunteers maintain the park's authenticity for the public and expand what they offer. Upgrades include a new elevator & hoist way, HVAC system, roofing, building drain system, accessible restrooms, accessible commercial kitchen, accessible parking layout, and new ADA pathway. Work will:

- Update the existing kitchen with new appliances, new casework, and finishes, and install a new vent hood and code compliant fire suppression system;
- Modify the floor plans and fixtures of both the ground floor and second floor bathrooms to meet accessibility code requirements;
- Construct additional offices in Men's Dormitory space and extend the walls to enclose the existing offices adjacent to Men's Dormitory.
- Relocate the existing door into the office space adjacent to the Men's Dormitory (formerly the Men's restroom);
- On the east side of Eagle Cottage, excavate to install a foundation for both an elevator to serve the basement, first and second floors, and an elevator machine room and modify interior spaces, as needed, for elevator shaft entrances;
- Modifiy the east exterior wall to provide access to building;
- Replace existing roofing and roof drainage system; and
- Excavate and install a new ADA compliant ramp to the new elevator and entrance.
