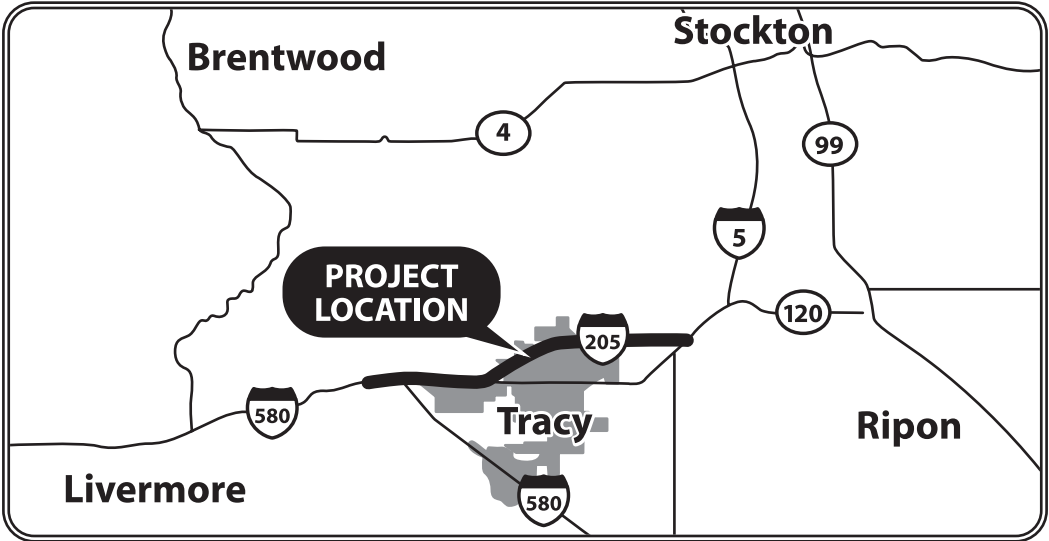

PUBLIC SCOPING MEETING I-205 MANAGED LANES PROJECT

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans), in cooperation with the San Joaquin Council of Governments, proposes to install managed lanes on Interstate 205 between Interstate 580 and Interstate 5. Examples of managed lanes being considered for the proposed project would be high occupancy-vehicle lanes, transit lanes, and express (or toll) lanes. The project is proposing four build alternatives and one no build alternative. Three of the four build alternatives would involve widening. Alternative 2 would involve partial widening while alternative 4 and 5 would involve widening the length of the project area. Alternative 3 would not involve widening but would convert an existing lane into a managed lane. Alternatives including widening would also include alterations to overcrossing and undercrossings, and interchanges would be reconfigured. Under all alternatives, the proposed project would include transit hubs, which could include park-and-ride lots, charging stations for electric vehicles, and bus or train stops.
