Project Title: Streambed Alteration Agreement No. 1600-2021-0021-R2, "Baldy" Timber Harvest Plan (THP) 2-20-00198-SIE

Project Location: The projects are located within the boundaries of a THP within watersheds Jones Valley, Jackson Meadow Reservoir, Milton Reservoir, Thompson Meadows, Haypress Creek and their connecting tributaries; Township 19N, Range 13E, Sections 5, 7, 9, 11, 17, 21, and 31 of the U.S. Geological Survey (USGS) 7.5-minute Quad Maps Haypress Valley and Sattley, Mount Diablo Base and Meridian.

Project Description: The projects are limited to the use of three instream water drafting sites, the repair of an existing rock armored crossing, and the repair of two roads adjacent to a class II watercourse. Further information can be found in THP 2-20-00198-SIE.
