The California Department of Transportation (Caltrans) proposes to regrade the median cross slopes from the existing 6:1 or steeper to 10:1 or flatter on Interstate 15 (I-15) at various locations from Harvard Road to Razor Road to improve safety. The work would include installing rock slope protection, extending culverts, constructing drainage inlets, and installing metal beam guardrails (MGS) as needed.

- The project includes three segments:  
 - Segment 1: Post Mile (PM) R96.1 to R103.5  
 - Segment 2: PM R111.6 to R112.3  
 - Segment 3: PM R120.1 to R124.24
