**Project Description:** The City of Redlands (City) proposes upgrades to the existing City owned wastewater treatment plant located at 1950 Nevada Street to handle future inflow and improve system reliability. City studied the effects this project may have on the environment and documented the findings in the Draft Initial Study (IS). Our studies show that the proposed upgrades will not significantly affect the quality of the environment. This notice is to advise you of the preparation of the Initial Study with Mitigated Negative Declaration (MND) and of its availability for you to read and provide comments.

The project site is on a list compiled pursuant to Government Code Section 65962.5.

**Public Review Process:**

This is to advise that there is no substantial evidence of any potentially significant environmental effects from the proposed project, and the City of Redlands has determined that a Mitigated Negative Declaration is the appropriate CEQA environmental determination for the project. The City of Redlands City Council will hold a public hearing at a future noticed public meeting (date to be determined) to discuss and make a decision on the above-referenced project. After public review of the Initial Study is completed, the City may propose to adopt a Mitigated Negative Declaration in accordance with the CEQA Guidelines.
