**Project Title:** EMERGENCY PERMIT FOR TREATMENT OF HAZRDOUS WASTE, BIOMARIN PHARMACEUTICALS, INC, SAN RAFAEL, CA

**Statutory Authority:** California Health and Safety Code, Chapter 6.5

**Project Description:** The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Code of Regulations, Title 22, Division 4.5, Chapter 20, Section 66270.61, has issued an Emergency Permit to the BioMarin Pharmaceuticals, Inc, (EPA ID# CAR000257337) to treat hazardous waste through a controlled reaction with a chemical solution. Specifically, the following chemicals consisting of 2-Butanol (1x4 Liter) and Benzyl Ether (1x1 Liter), must be stabilized prior to transport to an authorized hazardous waste treatment, storage, and disposal facility.

These chemicals are currently being stored at BioMarin Pharmaceuticals, Inc located at 791 Lincoln Avenue, San Rafael, California. DTSC has determined as a safety precaution to prevent an accident or severe injury, an Emergency Permit should be issued to chemically stabilize the hazardous waste prior to storage and eventual transportation off-site by Clean Harbors Environmental Services (CHES).

**Background:** Peroxide forming chemicals may spontaneously decompose and become explosive with or without external energy. Reactions are easily triggered, which make transport of these waste chemicals hazardous. Chemical stabilization is recommended prior to transport to a permitted treatment, storage, and disposal facility.

**Project Activities:** The treatment of the hazardous waste involves the addition of solution to the containers in a controlled manner to reduce the reactive or ignitable characteristics of the chemical. Treatment will take place within a designated exclusion zone. Only technicians from CHES will be allowed in the exclusion zone. Movement, preparation, and treatment of the containers will be in accordance with established standards.

Within 10 business days of the expiration of this permit, BioMarin Pharmaceuticals, Inc will submit a final report, signed in accordance with Title 22, California Code of Regulations section 66270.11(d). The report shall include certification that the treatment area has been cleared of all residual hazardous waste generated from this emergency treatment and all generated waste has been properly managed.

The Emergency Permit is effective beginning October 22, 2021 and shall expire on December 20, 2021.

**Reasons Why Project is Exempt:** This action is necessary to prevent an emergency. Chemical stabilization of the chemicals is necessary prior to transportation to an authorized hazardous waste treatment, storage, and disposal facility to prevent accidental fire and/or explosion during transport.


