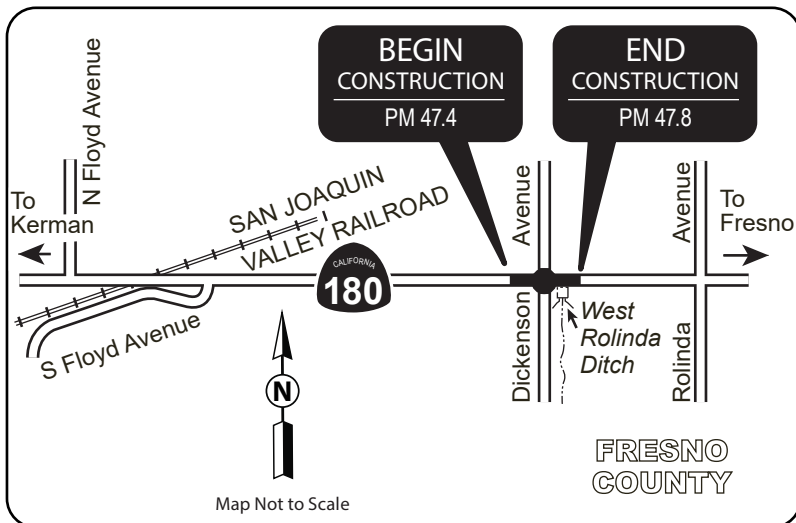


## Notice of Intent to Adopt a **NEGATIVE DECLARATION** (Study Results Available) and **OPPORTUNITY** for a **PUBLIC HEARING**

Do you want a public hearing on changes proposed in Fresno County on State Route 180 for the Dickenson Avenue Roundabout?

### PUBLIC COMMENT PERIOD

Comments will be accepted from **October 22, 2021 to November 23, 2021**. If there are no major comments or requests for a hearing, Caltrans will proceed with the project's design.



### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to construct a roundabout at the intersection of State Route 180 and Dickenson Avenue, between post miles 47.4 and 47.8 in Fresno County.

### WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. This notice is to inform the public that an Initial Study with Proposed Negative Declaration has been prepared for the project and is now available for review and comments. This notice also offers the opportunity to request a public hearing.
