A request to amend Chapter 17 (Zoning) of the Moorpark Municipal Code and an existing development agreement for the property located at 14349 White Sage Road in Moorpark, California. The amendments would allow for additional uses on the subject property with approval of a Conditional Use Permit, including laboratories, manufacturing and assembly, film production, and warehousing. The subject property is zoned Commercial Planned Development (CPD) and consists of a 100,000 square-foot building that includes a 15,000 square-foot retail showroom and 85,000 square-foot warehouse/distribution facility (Warehouse Discount Center). No development is proposed with this request.
