The Rancho Calera Specific Plan was originally adopted by the City in May 2011 and assessed as a component of the 2040 General Plan Environmental Impact Report (EIR). The Applicants have submitted the following applications for processing:
 - Specific Plan Amendment/Overlay
 - General Plan Amendment
 - Zoning Map Amendment, including the addition of the Specific Plan overlay designation
 - Tentative Map 21-0010 - 141 Lots
 - Development Agreement
