Description of Nature, Purpose and Beneficiaries of Project:

Treatments will target roughly 100-300 trees per acre with the majority of trees to be treated ranging from 4-8" DBH for removal. Residual trees within this size class, will be spaced such that no tree will be closer than 14 feet to another. Treatments in all units will cut down trees under 8" DBH, and this material will either be scattered to a height not to exceed 18" off the ground or piled
