# Notice of Intent to Adopt a Mitigated Negative Declaration

Pursuant to California Environmental Quality Act (CEQA) Section 21092 and CEQA Guidelines Section 15072

**PROJECT TITLE:** Big Sandy Rancheria Wastewater System Improvements (Project)

**APPLICANT:** Big Sandy Rancheria of Western Mono Indians of California (Applicant)

**LEAD AGENCY:** State Water Resources Control Board (State Water Board)

**PROJECT LOCATION:** Big Sandy Rancheria, one mile east of Auberry in Fresno County

The Project site is not present on any of the lists enumerated under section 65962.5 of the government code.

**PROJECT DESCRIPTION:** The project involves the construction and operation of a new wastewater treatment plant (WWTP) and associated wastewater collection system within the Big Sandy Rancheria. The project site consists of the area in which the following components would be located: the proposed WWTP site; proposed wastewater collection pipelines and two lift stations that would accommodate 57 service connections; abandonment of 56 existing septic systems; and electrical improvements to facilitate the new components.
