**Project Description**

The California Department of Transportation (Caltrans) proposes an emergency Director's Order project to address damages caused by the Tamarack Fire along State Route (SR) 89 between post miles 10.31 and 19.40, in Alpine County. The Tamarack Fire started on 07/04/2021 and burned over 68,696 acres. On 07/23/2021, Governor Gavin Newsom signed a Proclamation of State of Emergency for the Tamarack Fire. The scope of work includes removing burnt trees within 100 feet of the roadway centerline and trees beyond that 100-foot limit if they pose a threat to those traveling on SR-89, re-establishing drainage ditches, replacing damaged deer fencing, and installing erosion control measures where necessary. The purpose of the project is to immediately secure exposed slopes, remove hazardous trees, and rectify other damages caused by the fire prior to the upcoming winter season. The project is needed to prevent the loss or impairment of life, property, or essential public services along this section of SR-89.

Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.
