Project Description

The California Department of Transportation (Caltrans) issued a District Director's Order to replace damaged pavement on the Northbound (NB) off ramp from State Route (SR) 505 near postmile 6.53 to County Road 27, in Yolo County. A big rig traveling on NB SR 505 caught on fire at the top of the off ramp near postmile 6.53. As a result of the incident, pavement, hot mix asphalt (HMA) dike, and pavement markers and markings were damaged. This problem must be arrested as soon as possible in order to avoid the failure of travel way. This project was needed to avoid failure or threat of failure to the transportation system, which can result in the loss or impairment of life, health, or property.
