On southbound I-805, the eastbound H Street off-ramp's existing pavement has deteriorated beyond repair. The ramp will be rehabilitated by removing a 1.8-inch layer of existing pavement and replacing it with 1.8-inch layer of rubberized hot asphalt mix with no expansion. All work is within Caltrans right of way. Conditions listed on the Environmental Commitments Record must be met. If there are any changes to project impacts or project footprint, Caltrans Environmental must be notified.
