NOTICE OF AVAILIBILITY DRAFT INTIAL STUDY/MITIGATED NEGATIVE DECLARATION REPORT AND PUBLIC COMMENT PERIOD FOR THE FISHER CREEK DETENTION BASIN EXPANSION PROJECT

The proposed Fisher Creek Detention Basin Expansion Project would excavate approximately 10 feet of material out of the existing basin to increase the depth from 13.7 feet to 23.7 feet, and introduce more storage capacity. The project would excavate approximately 50,000 cubic yards (CY) of soil over the course of five weeks. This material would be excavated from the toe of the slopes, an area of roughly 2.77 acres, rendering the basin bottom 10 feet lower than the existing elevation. The proposed project would result in the removal of 56 trees on site, including 37 red willows and 19 Fremont cottonwoods. Materials from the excavation would be disposed at the Kirby Canyon Landfill or, if determined appropriate to serve as construction fill, sent to a development site in the City in need of surplus soil, which would reduce the length of trips needed to deposit and dispose of the dirt this summer.

A Draft Initial Study/Mitigated Negative Declaration Report (IS/MND) has been prepared by the City of Morgan Hill as Lead Agency to evaluate the environmental impacts of the proposed project. The Fisher Creek Detention Basin Expansion Project will not have significant environmental effects with regard to any environmental impact areas with mitigation incorporated.
