Project Title: Anderson River Park Trail and Levee Storm Damage Rehabilitation

Project Location - Specific: Township 30N, Range 4W, Section 12

Description of Nature, Purpose, and Beneficiaries of Project:

The project includes repairing the levee and river trail to its original condition that existed prior to the damage caused by flooding in early 2017. Areas where erosion and undercutting of the levee occurred along the Sacramento River side of the levee will be filled with rock slope protection (RSP) to restore the levee profile and prevent further erosion and undercutting of the levee. Work includes installing a base of 1-ton rock, then placement of ½-ton rock into the eroded areas. The 1-ton rock will be installed on benches above the waterline during low flow conditions. The ½-ton rock will then be placed on top of the larger rock. The RSP will be placed in six areas along the levee ranging from 13 to 120 feet in length. Approximately 500 cubic yards of rock will be placed to repair the eroded areas of the levee. Additionally, approximately 552 feet of the walking trail will be reconstructed along the eastern portion of the levee.
