Description of Nature, Purpose and Beneficiaries of Project:

The work includes providing all labor, materials, and equipment to install and commission new cathodic protection systems to prevent corrosion to the two-mile water transmission pipeline that connects the Rainbow Hills Pump Station and Rainbow Heights Pump Station. The work consists of the installation of two impressed current deep anode ground bed systems, flange isolation kits, test stations, and joint continuity bonds. Flange isolation kits would be installed at the beginning of the project and the isolation at the pumphouses would be confirmed before connection to the impressed current system.
