The Project is exempt under Section 15301 because there is no possibility that the Project will have a significant effect on the environment. 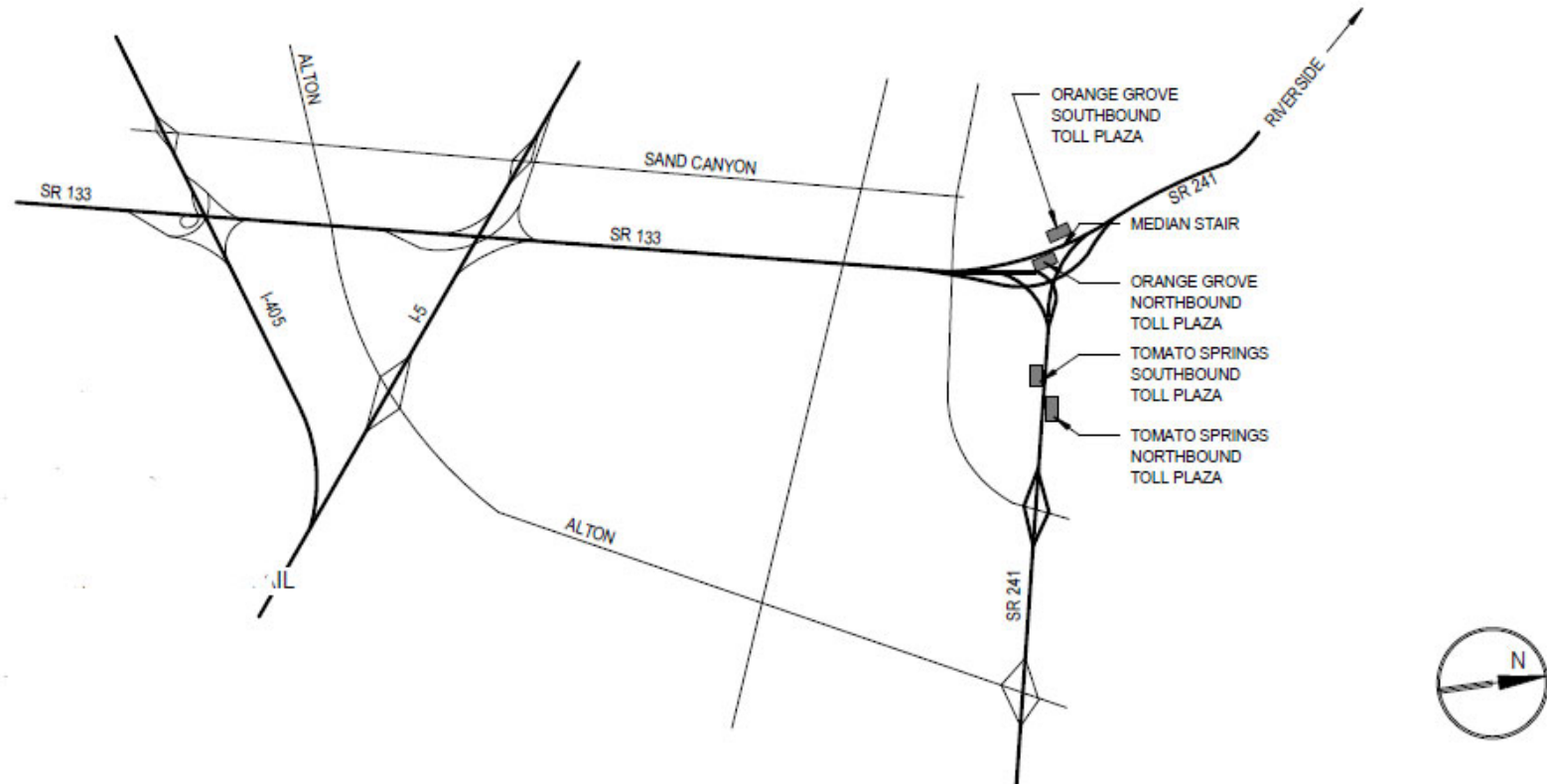


FIGURE 1: Project Location
