

Notice of Availability (NOA) of an Initial Study with Proposed Mitigated Negative Declaration (MND) / Environmental Assessment (EA) for the Interstate 80 / Ashby Avenue Interchange Improvement Project and an Announcement for a Virtual Public Open House



WHAT'S BEING PLANNED: The California Department of Transportation (Caltrans) District 4, in partnership with the Alameda County Transportation Commission (Alameda CTC), proposes to provide interchange and local road improvements along Interstate 80 (I-80) at the Ashby Avenue Interchange (interchange). The interchange is located between post miles (PM) 3.9 and 5.0 on I-80 and between 13.7 and 13.9 on State Route (SR) 13 in the cities of Emeryville and Berkeley in Alameda County. The proposed project would replace the existing elevated interchange connector ramps with a new bridge over I-80, realign access to West Frontage Road, and introduce a new bicycle and pedestrian overcrossing and connection from 65th Street / Shellmound Street to the San Francisco Bay Trail.

WHY THIS AD: Caltrans has studied the effects this proposed project may have on the environment. The results of these studies are summarized in the draft environmental document known as an Initial Study (IS) with Proposed Mitigated Negative Declaration (MND) / Environmental Assessment (EA). The purpose of this notice is to inform the public of the availability of these draft documents to any interested individuals, to provide the public an opportunity to comment, and to notify the public of an online presentation and question and answer (Q&A) session (details below).

You can also attend a live, online public meeting on January 11, 2022.

PUBLIC MEETING: Based on the Governor's Executive Order and Department of Public Health recommendations, in-person public meetings will not be held to maintain social distancing requirements.
