The proposed project consists of a fully paved, striped, and fenced approximately 393-stall container parking lot to be used for loading/unloading and parking of shipping containers, as well as a planted landscape area, located at 1599 John S. Gibson Boulevard, San Pedro. Access to the proposed site would be provided via driveway along John S. Gibson Boulevard, The proposed Project also includes retaining walls up to approximately 30 feet in height. The proposed Project would optimize the use of existing land that supports container storage at the site, provide landscaping to improve site conditions and slope stabilization, and provide a facility to alleviate truck traffic congestion within the Port.


