Approval Action Under Consideration by DTSC: Emergency Permit

Statutory Authority: California Health and Safety Code, Chapter 6.5

Project Description: The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Code of Regulations, Title 22, Division 4.5, Chapter 20, Section 66270.61, has issued an Emergency Permit to NCL (EPA ID# CAL000045874) to treat hazardous waste through a controlled reaction with a chemical solution. Specifically, the following containers, one (1) container of Acetaldehyde must be stabilized prior to transport to a permitted treatment, storage, and disposal facility.

The hazardous waste item is expired and is currently being stored on the NCL campus located at 5680 W End Rd, Arcata, CA 95521. DTSC has determined, as a safety precaution to prevent an accident or severe injury, an Emergency Permit should be issued to chemically stabilize the hazardous wastes prior to transportation off-site by Clean Harbors Environmental Service (CHES).

Background: The chemical noted above is either peroxide forming materials or temperature sensitive materials. The chemical produces peroxide compounds as they degrade (i.e., after the product's expiration date). The peroxide produced may be unstable at relatively low concentrations, resulting in fire and/or explosion if improperly handled. Static electricity or heating from sunlight may be enough to trigger some reaction, making transport of non-stabilized chemicals hazardous. Chemical stabilization is recommended prior to transport to a permitted treatment, storage, and disposal facility.

Project Activities: The treatment of the hazardous waste involves the addition of solution to the containers in a controlled manner to reduce the reactive or ignitable characteristics of the chemical. Treatment will take place within a designated exclusion zone. Only technicians from CHES will be allowed in the exclusion zone. Movement, preparation, and treatment of the items will be in accordance with established standards.

Within 10 business days of the expiration of this permit, NCL will submit a final report, signed in accordance with Title 22, California Code of Regulations section 66270.11(d). The report shall include certification that the treatment area has been cleared of all residual hazardous waste generated from this emergency treatment and all generated waste has been properly managed.

The Emergency Permit is effective beginning December 17, 2021 and shall expire on February 17, 2022.

Reasons Why Project is Exempt: This action is necessary to prevent an emergency. Chemical stabilization of the chemicals is necessary prior to transportation to an authorized hazardous waste treatment, storage, and disposal facility to prevent accidental fire and/or explosion during transport.
