

**NOTICE OF INTENT TO ADOPT A  
MITIGATED NEGATIVE DECLARATION**

Notice is hereby given that the public agency named below has completed an Initial Study of the following described project at the following location: Southeast corner of Bear Valley Road and Amethyst Road APN No. 3072-211-13, 3072-211-14, 3072-211-15, & 3072-211-16

Project Description:	A Site Plan to allow for the construction of a 98,000-square foot commercial shopping center on a 11.2-acre project site that includes seven commercial structures for retail, restaurant, and office uses as well as associated public improvements.
Project Location:	Southeast corner of Bear Valley Road and Amethyst Road; APN: 3072-211-13, 3072-211-14, 3072-211-15, & 3072-211-16; Within the City of Victorville, County of San Bernardino, State of California, San Bernardino Meridian, Section 1, Township 4N, Range 5W.

This Initial Study was completed in accordance with the Lead Agency's Guidelines for Implementing the California Environmental Quality Act (CEQA). This Initial Study was undertaken for the purpose of deciding whether the project may have a significant effect on the environment. On the basis of such Initial Study, the Lead Agency's Staff has concluded that the project will not have a significant effect on the environment, and has therefore prepared a Draft Mitigated Negative Declaration. The Initial Study reflects the independent judgment of the Lead Agency.
