MITIGATED NEGATIVE DECLARATION**

Notice is hereby given that the public agency named below has completed an Initial Study of the following described project at the following location: Southeast corner of Olivine Road and Monte Vista Road APN No. 3133-271-1, 2, 5, 10, 11, 12, 13, & 15 and 3133-281-1, 3, 7 & 8

Project Description:	To allow for the recordation and development of a 194-lot single family residential subdivision (Tentative Tract Map 20188) with 7,200 sq. ft. minimum size lots, on an approximately 75 gross-acre building site that is vacant and undeveloped with an approximate density of 2.5 units per acre.	
Project Location:	Southeast corner of Olivine Road and Monte Vista Road; APN: 3133-271-1, 2, 5, 10, 11, 12, 13, & 15 and 3133-281-1, 3, 7 & 8; Within the City of Victorville, County of San Bernardino, State of California, San Bernardino Meridian, Section 32, Township 5N, Range 5W.
