The Alameda County Water District (District) proposes to carry out the Alameda Reservoir Improvements Project (project). The project is located at 585 Shoshone Court in Fremont, California. The purpose of this project is to replace the roof and roof framing system and seismically upgrade the reservoir. The seismic upgrade of the reservoir would include replacement of the roof, replacement of the reservoir's valve stem extension, installation of a new forced air ventilation system, and installation of new interior lighting. The construction would occur between September 1, 2022 and September 30, 2023.
