## NOTICE OF AVAILABILITY DRAFT ENVIRONMENTAL ASSESSMENT AND PROPOSED FINDING OF NO SIGNIFICANT IMPACT FOR TRANSMISSION LINE EASEMENT AT EDWARDS AIR FORCE BASE, CALIFORNIA

The United States Air Force (Air Force) announces the availability of a Draft Environmental Assessment (EA) and Finding of No Significant Impact (FONSI) for issuing an out grant for a 100-foot wide transmission line easement to a private sector applicant (Applicant). The Applicant proposes to construct, operate, and maintain an approximately 6.5 mile-long electrical transmission line across a portion of Edwards Air Force Base (AFB), California. The purpose of the Proposed Action is to support public interest by granting an easement for land within an approved utility corridor on Edwards AFB. This easement would allow the conveyance of energy produced by the Applicant's future photovoltaic solar facility to a Southern California Edison substation.

The EA, prepared in accordance with the National Environmental Policy Act (NEPA), Council on Environmental Quality regulations, and Air Force instructions implementing NEPA, evaluates potential impacts of the Proposed Action and Alternatives on the environment including the No Action Alternative. Based on this analysis, the Air Force has prepared a proposed FONSI. The Air Force seeks public comments on the Draft EA and Draft FONSI and will consider all input received before reaching a final decision.
