Description of Nature, Purpose and Beneficiaries of Project:

The purpose of the project is to reduce hazardous fuels which have built up as a result of the 2018 Tubbs fire. Fuels treatments will target roughly 100-300 trees per acre with the majority of trees to be treated will be under 8" DBH. Residual trees between 4-8" DBH will be spaced such that no tree will be closer than 14 feet to another. Treatments in all units will cut down dead trees under 8" DBH, and this material will either be scattered to a height not to exceed 18" off the ground or piled
