The Replenishment Water Project is covered by the evaluation of environmental effects in the Turlock Subbasin GSP PEIR (SCH# 2022010100) and is within the scope of the PEIR for CEQA compliance under CEQA Guidelines Section 15168. The Replenishment Water will not result in any new impacts nor require any new mitigation measures not covered in the PEIR.
