Project Title: Yuba City Wastewater Treatment Facility Outfall and Diffuser (Streambed Alteration Agreement EPIMS Notification No. SUT-30548-R2)

Project Location: Feather River, in the County of Sutter, State of California; Latitude 39.07015, Longitude -121.606381.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification Number SUT-30548-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, City of Yuba City.

The project is limited to replacing an existing, damaged, wastewater outfall and diffuser by constructing a new outfall and diffuser. The existing diffuser will be abandoned in place, with the new diffuser located downstream of Shanghai Falls in a stable location in the river.

This is to advise that CDFW, acting as a Responsible Agency, executed the above Lake and Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
