This project is a Site Approval application to expand an existing religious assembly facility to include the construction of 5,085 square foot two-story building. The first floor will serve as a 3,300 square foot dining room. The second floor will serve as a 1,785 square foot meditation room. The facility was previously approved for 81 attendees, and no increase in attendees is proposed with this application. The project site is served by an on-site well for water, a septic system for sewage disposal, and an on-site storm pond for storm drainage. The project site has direct access from East Foppiano Lane.


