



NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Notice is hereby given that the public agency named below, acting as Lead Agency, has completed an Initial Study of the following described project at the following location:	
Public Agency:	City of South El Monte
Project Name:	Starlite Residential Development
Project Description:	The proposed Starlite Residential Development project would result in the redevelopment of the 12.3-acre former Starlite Drive-in Theater site for residential uses with 207 dwelling units (169 single-family homes and 38 multifamily homes). An additional entry would be created off Chico Avenue at the eastern portion of the site. The proposed project would also include 9,000 square feet of recreational facilities (pool, pool deck, and recreation building).
Project Location:	The 12.3-acre project site is in the City of South El Monte at the former Starlite Drive-in Theater site at 2540 Rosemead Boulevard. The City is in the central portion of Los Angeles County and is bordered by the cities of El Monte to the north and east, Rosemead to the west, and Whittier Narrows Natural Area to the south. The project site is accessed off Rosemead Boulevard (State Route 164 [SR-164]), which runs north-south, and is one mile south of Interstate 10 (I-10), which runs east-west.
An Initial Study, reflecting the independent judgment of the Lead Agency, was completed in accordance with the Lead Agency's Guidelines implementing the California Environmental Quality Act. Based on this Initial Study, the City of South El Monte has concluded that the project, with the incorporation of mitigation measures, will not have a significant effect on the environment, and has therefore prepared a Proposed Mitigated Negative Declaration.
