The plan intends to respond to local and regional housing needs, promote economic growth, foster local job creation, enhance quality of life, and protect natural and agricultural resources. In addition to citywide planning issues, General Plan 2042 will provide goals and policies for enhancing downtown Los Banos as the vibrant center of the city and community.
