The purpose of the South Mokelumne River Setback Levee Project is to rehabilitate 3 levee sections, totaling 4,350 linear feet, and to create waterside habitat. Landside work includes constructing setback levees to the Delta Specific PL 84-99 Standard. Waterside work includes excavation of the existing levee to construct a habitat bench. The habitat benches and setback levee waterside slopes will be planted with native species. Construction is planned to occur in 2022, pending permit approvals.
