## NOTICE OF INTENT TO ADOPT AN INITIAL STUDY AND MITIGATED NEGATIVE DECLARATION

TO: Public Agencies, Organizations and Other Interested Parties  
FROM: City of San Mateo, Department of Public Works

**NAME OF PROJECT:** Poplar at Golf Course Trash Capture Project  
**LOCATION:** City of San Mateo, San Mateo County, California

**PROJECT DESCRIPTION:** The City of San Mateo (City) proposes to install a full trash capture device at the location immediately north of the intersection of East Poplar Avenue and North Bayshore Boulevard. The project would also provide native vegetation enhancement along Poplar Creek within the Poplar Creek Golf Course to offset project impacts to Poplar Creek. The project would enhance approximately 1,000 square feet (0.02 acre) of stream. Temporary irrigation would be installed, and a monitoring program would be instituted to ensure that the plantings for enhancement establish.

NOTICE IS HEREBY GIVEN THAT the City of San Mateo, California, intends to adopt a Mitigated Negative Declaration for this project. This Mitigated Negative Declaration is based upon a finding that there is no substantial evidence before the City that, although the proposed project could have a significant effect on the environment, there will not be a significant effect in this case, as project revisions have been made or mitigation measures have been included which will reduce potential impacts to less-than-significant effects. The reasons to support such a finding are documented by an Initial Study prepared by the City.

The City is releasing an Initial Study and Mitigated Negative Declaration (IS/MND) for the subject project for review and comment to all agencies, organizations, and interested persons. Reviewers should focus on the content and accuracy of the IS/MND in discussing potential impacts upon the environment.
