Project Title: Merced River Agricultural Diversion and Fish Habitat Enhancement Project - Cuneo (Streambed Alteration Agreement No. EPIMS-MER-44629-R4)

Project Location: The Project is located at an agricultural diversion site herein referred to as Cuneo Diversion, within and adjacent to the Merced River; in the unincorporated community of Snelling, County of Merced, California; Centered at coordinates 37.519005, -120.419082; Section 00, Township 5 South, and Range 14 East; U.S. Geological Survey map Snelling; Assessor's parcel numbers 043-050-015; 043-050-020; 043-050-052; and 043-050-023.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement (EPIMS-MER-44629-R4), pursuant to Fish and Game Code section 1602, to the project Applicant, Merced Irrigation District, as represented by Michael Morris.

The Project involves activities related to the modification of agricultural diversion infrastructure and improvements to in-channel spawning and off-channel rearing habitat located within the vicinity of diversion infrastructure.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on 5/1/2024 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the Mitigated Negative Declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A Mitigation Reporting or Monitoring Plan was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
