The project parcel fronts on Durham-Dayton Highway, a publicly-maintained paved road. Future residences will be served by individual wells until Durham Irrigation District water is available. The parcels will be served by individual septic systems. The parcels will be served a proposed cul-de-sac within a 60-foot easement.
