The scope of work for the project will include repairing and replacing existing roadway and damaged culverts; bridge rehabilitation work on 3 bridges (Owens Creek, Miles Creek, and Deadman Creek); and replace the Mariposa Creek bridge with a new elevated bridge, to eliminate the continued flooding that occurs in the area.
