### DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

The proposed project is a Use Permit for a six foot solid wood fence located within the required front yard setbacks (corner lot), on a 1.43 acre parcel within a designated Scenic Corridor.

### EXEMPT STATUS:

Categorical Exemptions Section 15303 (New Construction or Conversion of Small Structures), which provide for the new construction of small accessory structures.

### REASON WHY THIS PROJECT IS EXEMPT:

The proposed project is categorically exempt from the provisions of the CEQA Guidelines pursuant to the Provisions of Title 14 of the California Administrative Code, Section 15303(e) (New Construction or Conversion of Small Structures) involving negligible expansion of use and only minor construction, including gates and fences.

No exceptions listed under Section 15300.2 apply. There is no reasonable possibility that the project would have a significant effect on the environment.

This Notice of Exemption is filed pursuant to the provisions of Section 15062 of the State CEQA Guidelines.
