Project Description

The California Dept of Transportation (Caltrans) proposes to replace the existing roof of the Caltrans Whitmore Maintenance Station in Placer County on State Route (SR) 80 at post mile 50.7. The scope of work includes removing the carport roofing down to the plywood sheathing. Caltrans will remove materials such as plywood sheathing, wood roof framing, fascia, CMU seal plates. Caltrans will also remove column pedestals and re-grout column base plates as needed. Caltrans will apply paint to all-steel elements and the fascia. Finally, work will include re-roofing the carport, and all flashing details (penetrations, curbs, expansion joints) shall follow the manufacturer's requirements. All work will be within the State's right-of-way.
