The California Department of Transportation (Caltrans) issued a District Director's Order to replace a failed culvert on State Route 89 near postmile 17.44, in Sierra County. Damage assessment concluded the existing 36-inch corrugated steel pipe has failed and caused the sinkhole to appear on pavement. This problem must be arrested as soon as possible in order to avoid the failure of travel way. This project was needed to avoid failure or threat of failure to the transportation system, which can result in the loss or impairment of life, health, or property.
